Dear friends,

Minutes of the 5th Governing Council (2021-22) of Kerala Catholic Society held on 05th March, 2022 at KCS House, 23 Halls Road, Kilpauk, Chennai -600010 at 6 pm

**Approval of Minutes**: The minutes of GC held on 13th February, 2022 was circulated and passed

**Review of Accounts:** Accounts for the month of February,2022 was circulated and approved after discussion.

**Dialysis Project:** The GC has been updated about the present status of the Dialysis Project, as follows:

- Total contribution collected Rs.71.60 lakhs.
- Contribution from Members Rs.40.20 lakhs.
- Contribution from Corporates Rs.23.40 lakhs.
- KCS will issue cheque (1) Rs.40.20 lakhs to Rotary Foundation and (2) Rs. 23.40 to Rotary Trust which has the CSR certification. (From Rotary Trust the amount will be transferred to Rotary Foundation)
- Donors of Rs.40.20 lakhs will be eligible for IT exemption u/s 80G of IT Act.
- Corporate Donors of Rs. 23.04 lakhs will be eligible for CSR Fund utilization,
- based on relevant Utilization Certificates issued by the Rotary Trust and KCS Auditor.
- KCS Auditor has cleared and approved the accounting methods of aforesaid Receipts and Payments as per the provisions of the Charitable Society Act, to avoid technical / commercial issues of this project, in future.
- Total 12 Machines, out of which 9 Machines will be sponsored by KCS.
- Corporates' names will be labeled on Machines, sponsored by them.
- KCS name will appear along with RCMW and TF in the hospital.
- Trying to inaugurate the facility by a VVIP at an early date.

#### IT demand:

Except one year (AY 2014-15) for rest of the years - (i.e) AY 2017-18, 2018-19 and 2019-20, Condonation Orders have been issued by the Commissioner of Income Tax (Exemptions)

and based on these Orders we have to get the 'giving effect CIT order' from the Assessing Officer. We had filed petitions for condonation of delay in filing the Audit Report in Form 10 B, along with the Annual Return. Condonation Order for AY 2014-15 is also expected to be issued.

Members appreciated the efforts of the Auditor for this relief from IT liability.

#### **Silver Jubilee Mass:**

It was discussed and decided to have a Thanksgiving holy mass / Jubilee mass at 4.30 pm (Saturday) 02nd April, 2022 at Santhome Cathedral with His Grace ArchBishop as the main celebrant along with our Patron Fr. Further, it was decided to serve boxes of snacks and fellowship after the mass, in the hall behind the church and remind the members of the Jubilee meeting day (i.e) June 04th, 2022.

It was decided that a virtual meeting will be held on Sunday, 20th March,2022 to finalize the nominations received for the sake of Honour Award, by Mr. George Zacharia, Mr. V.A. George and Mrs. Susan Mathew, along with the President and Secretary.

It was decided to form a Nomination Committee with immediate past President, Vice President and past lady member in the GC to nominate three new members in place of the retiring members viz; Mr. E.C Thomas, Mrs. Lekha Antony and Mr. M.S. 
