Extracts of 9th GC Meeting on July 10, 2021

Approval of the Minutes: Minutes of the GC meeting held on 13.06.21 was circulated and approved after discussion.

Review of the Accounts: Accounts for the month of June, 2021 was circulated and approved after review.

AGM: Due to the current COVID pandemic situation, it is proposed to conduct the AGM on 31.07.21 (Saturday) @ 6 p.m. at KCS House.

Onam on August 14th: It is suggested that a virtual POOKKALAM competition be conducted zone wise and give prizes (1st, 2nd, and 3rd) for the winners. Further a consolation prize be also given to every participant as a motivation. Due to various practical reasons, it is suggested to drop Onam Sadhya and instead celebrate a Family Day in a Kalyanamandapam, on a convenient day, later.

Membership fee: It is proposed that a revision in subscription amount is required, and the proposed amount is Rs.10,000/- per member, if one more member is there in the same family, then there will be deduction of 10% in amount (i.e) the second member can be admitted for Rs.9,000/- as a member. One Time payment of Rs.4000/- per person can also be considered along with the proposal of Rs.1,000/- NRI, it is suggested.

Web site: It is decided to launch the KCS web site in the AGM (i.e) on 31.07.21.

KCS Directory: It is requested to collect the details of all members by 31.07.21.


Subscription: As the last date for remittance of subscription is over, it is decided to send a 2nd reminder letter to the members to get it before the AGM.

KCS – Why and What Next Some Wild Thoughts



As a society KCS has survived 25 years. We look at the future existence with anxiety. Facts about attendance, enthusiasm and neglect have been reported by the present President and appointed committees.

Can we look back even as some are suggesting that we enlarge our circle by not being parochial. You look at the name of the Society. Kerala and Catholic. If you don't accept these distinctions, we cannot be together. Kerala born Catholics. Is there anything special in it by way of habits, food, ethics, traditions, worshiping practices? If yes, you are eligible to be part of KCS. Some of us elders consider this as a privilege and want it to be so. Why? because we and our parents are products of that culture having lived in Kerala at least for part of our life. We studied mostly in Christian schools, believed in our heritage, having considered ourselves Christians even before Europeans were.

Perhaps our next generation may not hold this as a matter of pride as they lived in a more secular environment; have more non-Christian friends and some have non Christian life partners. How can we expect them to be so particular about "Kerala Catholic"? My personal experience with my next generation in larger family is that 20% are in that category having Punjabi Hindu in laws. The last 18 months in isolation for us has created a gap in helpline contacts and fellowship meets. This will be reflected in the future activities also.

As for fellowship and charities can we not do it through the local clubs or other organisations like Rotary, Lions etc.? If you think that being in KCS, in fellowship you are getting an extra feeling/comfort then that alone is the guarantee for continued interest in KCS.

In the way forward, a better organisational structure will be with more number of small clusters for closer interactions - Helpline redefined with Max 10 families and central events can be of now with 4/5 events annually. Such a grouping may also help the younger ones to be more active .Geographical spread of the city also demands that this be the pattern.

GC should encourage wider discussions on this from existing members.
