Dear Friends,

GC members expressed the view that the decisions of the GC should be circulated to all for transparency. GC considered the suggestion in the meeting of 5th December,2020 and it was decided to include a summary of GC deliberations in the newsletter.

Summary of GC discussions

The pace of collection of subscriptions was discussed. It was pointed out that only 67 members paid the subscriptions as on date. President was asked to write explaining the dire financial situation of KCS to members, particularly about the high demand notice for water and sewage taxes. KCS has paid under protest Rs.97,440/- as property tax for the period up to March 2021, retrospectively charged from 2011 as demanded by the Govt. authorities under threat of sealing KCS house. Water& Sewage tax of 76,114 is pending to be paid.

Report of the team who visited Elavur property was presented. We receive several enquiries. Office Manager was asked to visit the property with prospective agents and buyers.

Very nice! Also, nice to see that the Vice President and Treasurer are young people. - Rajesh Thomas, NRI, US President informed that the recommendations of Empowered Committee were already circulated to the members. On getting their response by 7th January, 2021, EGM notice will be sent with 21 days' notice.

It was decided all statutory payments must be paid promptly as also filing of society registration and income tax returns before due dates to avoid litigation form regulatory and revenue authorities.

Received only 18 applications for the scholarship/ medical assistance this year. Since this is within the total allowed limit, it is decided to give Scholarship to all the applicants.

KCS Secretary will seek a meeting with the Auditor to ensure statutory requirements with various Govt offices viz: remittance of payments / Filing of Returns / Submission of reply to queries/duration of keeping of records etc.

Month wise checklist of events (yearly calendar) is to be prepared with details of KCS programs to help members for better planning of their personal planning and schedules. It

was also decided that a user friendly KCS Web site would be installed including the revised KCS directory.
