From the desk of KCS President

Dear friends,

We have just come out of a long lock down of the city. The citizens of this great metropolis have beaten the second wave of coronavirus with some success. It is needless to state that due care must be taken to beat the third wave that is expected later in the year by strictly following covid protocols.

We plan to call the AGM towards the end of July. Notice with mandatory 21 days will be sent shortly. Empowered Committee recommendations have been circulated for your valuable suggestions. We hope to have an in person meeting with provision for virtual attendance. The KCS office will contact you to get to know how many could attend in person. Your cooperation is requested.

Our planned programmes are at a pause. I discussed its practicality of celebrating our scheduled Onam celebration on August 14 with past Presidents, senior members, and GC colleagues. The consensus is that we cannot have much of a celebration with masks and social distancing. Moreover, many expressed their apprehension of being in a closed hall with air conditioning.

I understand that no zonal helpline meetings happened during the last one year. One of the recommendations of the Empowered committee (Its recommendations and related resolutions have been sent to you already) is to federate zones to let them have their own celebrations for better attendance and interaction. The zones could decide to celebrate Onam in their own innovative ways. The leaders of Anna Nagar zone have come up with an idea of virtual celebration of Onam. Zonal leaders may contact me, for any KCS involvement, if needed for zonal meetings.

A word about annual subscriptions. I have dealt with this unpalatable subject before. I am happy to report that all members have paid their subscription last year except for a couple of members although it needed some effort. We request the same cooperation this year too. Some members are of the view that the subscriptions need not be paid as there were no programmes. While I appreciate that it is their will and pleasure to pay or not, it may be noted that subscriptions are a yearly fee for the right of membership of an organisation and are required to meet due infrastructural and overhead expenses. It is well known that programmes could not be held due to health concerns of members who are mostly seniors as well as due to covid protocol by the Government. As a matter of fact, it is a personal disappointment to me and the GC of 2020-2021 that all our well laid out plans were cancelled due to covid. I look forward to having our silver jubilee celebration in December.

I hope that you will agree that ours is a social organisation. We are not equipped to operate like well-founded and funded NGOs or church organisations with solid infrastructures. We had formed a task force with me as the convener to help members in need and informed members. We reached out to those members who were affected by covid, offering counsel and services. From our Project Trust fund, we are reaching out to needy victims of covid who have been left out of largesse from Government or other service organisations. Vice -President Mr. Oommen Abraham and Trustee, Mr. Soy Joseph are in this effort.

KCS is in the process of identifying around 50 families who are migrants, daily wage labourers who do not have any job now, physically challenged or who do not have any other means to meet their family needs. In this regard it is working with Corona Sevai Maiyam run by Mr. Abraham Lincoln in North Chennai. We will share more details and pictures in the next issue. It is proposed to meet the cost of the 50 kits from the Trust amount approximately Rs.1,000/- per kit.

Request to be generous:

There are many members who want to do something for the needy and expressed in whatsapp group. In case anyone wants to contribute, please feel free to contact any of the GC members. There are lot of people asking for help and I am sure there is a lot of savings to us in the last one and half years otherwise we would have normally spent like travel, clothes, dinner outs, etc. There are lot of people struggling to meet their ends as they lost job due to Corona. There are families who are not able to meet their medical expenses due to Corona where more than one member in the family is affected. KCS members for helpline meeting used to spend some money every year, since there was no helpline meeting for the last one and half year, at least that amount may be contributed to the benefit of Corona affected families. In KCS we have around 100 active members and if each member contributes Rs.1,000/-, easily we can contribute Rs.1 lakh for the needy
