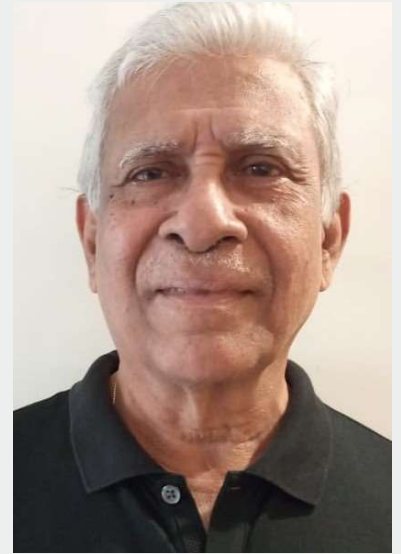


President message

Hope to meet all of you on June 4.

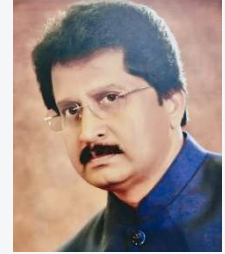
KCS VISION
